

## **Degree Audit Reporting System**

#### **Efficient and Effective Tool**

- Program planning
- Graduation checking

## **Used By**

- Students
- Staff: Advisors, Counselors, Faculty, Registrars

#### **Accurate and Consistent Information**

- Reduces risk of surprises for student when applying for graduation
- Reduces graduation processing time

## **Degree Audit Reporting System**

#### **Web-based Tool**

- Students can login on any device
  - Can run degree audits for declared majors
  - Can run degree audits for "What-If" majors
- Students run 17,000 audits per month

## **Lists Degree/Program Requirements**

- Courses that have been taken
- Courses that are still needed
- Transfer courses
  - How they transfer
  - How they apply to program
- Residency
- Different GPAs by graduation requirement such as:
  - Program required courses
  - Cumulative institutional
  - Cumulative college-level courses
  - MnTC/GenEd courses

## DARS through eTranscript

#### **SIS Tool**

- Allows receiving institution to access student's degree audits from other Minnesota State sending institution(s)
  - Student must be admitted
  - Student must have had program declared in SIS at one point in time
- Allows staff to clearly determine which program requirements were met at sending institution
- Receiving institution staff will have access to:
  - Verification of MnTC Goal Area course completion
    - 10 Goal Areas
    - 40 credits minimum
  - Non-system institution course equivalencies
  - Progress toward degree program completion

## **DARS** through eTranscript

#### **SIS Tool**

- Helps ensure that correct course goal areas are awarded to student at receiving institution
  - Reducing both student cost and time to program completion
- Assists in determining course equivalencies for all courses in general
- Admission Office benefits:
  - Easily able to determine the program the student was following at sending institution
  - Ensures transfer agreements, partnership, and Transfer Pathways are followed

# Transferology®/Transferology® Lab

#### Web-based Tool

- Institutions provided with a license
- Equivalencies and degree audit carry over
- Users can see both how courses transfer and how they apply to a degree
- Also allows for communication
- Transferology Lab allows institutions to access information nationwide
- Transfer Pathway display
- Engagement up to each institution
  - Communication
  - Marketing
- Data
  - 9,375 audits were run last year
  - 1,754 accounts were created

# **Transfer Evaluation System (TES®)**

#### **Web-based Tool**

- The Transfer Evaluation System is an online solution for researching credit, tracking evaluations, and managing equivalencies.
- Research TES database houses millions of course descriptions, institution profiles, and a detailed history of catalog changes.
- **Evaluate** The **Evaluation Tracker** in TES provides a convenient workflow for routing equivalency decisions to faculty. All user actions and the results of the process are stored for later review and to provide account administrators with a snapshot of the institution's responsiveness to transfer credit.
- Manage Equivalencies Stage equivalencies between any number of courses, match to user-defined generic courses, proactively explore equivalencies using powerful algorithms that generate potential matches for you.

# **Transfer Review and Appeal**

- When students determine that a course hasn't transferred correctly they use the tool in the student registration system to submit a review request
- Students can attach documentation to the request
- Tool allows communication between reviewer and student
- If review is denied students can appeal with the institution
- If the appeal at the institution is denied the appeal goes to the system office
- Allows us to gather data on these appeals

### **Graduation Planner and Schedule Builder**

#### **Students and Advisors**

- Planner uses existing degree audits
  - Personalized term-by-term plans
  - Define a clear path to graduation
  - Can be created independently by students and/or with advisors
- Create Roadmaps from audits
  - Guided pathways created by schools
  - Recommended sample plans
  - Complete in defined timeframe
- Create a plan from audits or roadmaps
- Validate against the degree audit to verify completion
- Push planned courses to Schedule Builder
- Built-in notes feature

#### **Administrators**

- True course demand is captured
- Aggregate data can be analyzed
  - Better meet student needs
  - More efficient use of faculty and facilities

  - Receiving institutions can view degree audits for students from sending institutions electronically
- Reverse Transfer Reports
- Transfer Review and Appeal processes

- Geography
- Technical Colleges vs Community Colleges
- Open Admission
  - "Swirling" students
- Unions: MSCF, IFO, MAPE, MSUAASF, AFSME
- Student Associations: Students United | LeadMN
- Being student ready
- Degree Audits
  - Each campus handles/encodes their own degree audits
  - Format/layout can vary between institutions
- Establishing equivalencies in the databases
- 37 individual institutions with varying campus policies

# **Best Practices**

- MnTC General Education Package
- MnTC Goal Areas and Transfer Equivalencies
  - Clearly labeling which goal area(s) a course is in
  - Visible on Transferology
- Non-cluttered Degree Audit
  - No excess information
  - As clear as possible for the student
- Streamlined communication
  - Between campuses and system office
  - TES & Transfer Review and Appeal
- Direct equivalencies
