




Transfer Initiatives

Support state systems, public and independent higher education institutions, throughout the region by promoting and reporting on effective and seamless transfer policies.

The Guarantee:

- Planning grant funded in 2019 for southern states (7 months)
- Implementation grant funded in 2019 for southern states (3 years)
- Planning grant funded in 2021 for northern state expansion (8 months)

What is the New England CollegeTransfer Guarantee?

State-specific systematic transfer for guaranteed admission between community colleges and four-year independent institutions in CT, MA and RI.



Planning Phase: Initial Activities

Cultivating buy-in

- 1. Partnered with CCIC and CSCU prior to planning grant submission
- 2. Met with legislature, the Governor's Office
- 3. Presented at regional conferences
- 4. Collected critical data
- 5. Hosted state specific convening to discuss the initiative (once funded)
 - a. Attendees included independent colleges and community colleges



Intent to Participate


- 1. Institutions signed non-binding) LOIs
- 2. Submitted LOI's with final report and implementation proposal

Why would CSCU want to participate

BUILDING UPON STATE TRANSFER POLICY FOR UNIFICATION

- The agreement creates competition for the 4yr schools within our system. Is that a bad thing?
- It was a five-year difficult process to create our transfer policies. How can we allow other schools to participate without any buy-in?
- Overall, it comes down to data:
 - 63% of our community college students are transferring to 4-year schools outside of our system
 - 60% of that population is doing so without a degree

Implementation Phase: Initial Activities

Phase One:

- 1. Establish CT Steering Committee
- 2. Draft Foundational Design and Guiding Principles

Phase Two:


- 1. Host multiple participating institution collaborative convenings and build consensus
 - a. Finalize Foundational Design / Guiding Principles
 - b. Framework30 and Transfer Tickets

Phase Three:

- 1. Develop and finalize Memorandums of Agreement (MOA)
- 2. Collect MOAs (rolling participation)
- 3. Collect Transfer Tickets (continuous)

Phase Four:

- 1. Establish websites (NEBHE / CSCU)
- 2. Develop promotional materials



"A DEGREE IS A DEGREE"

- Promoting a student-centered approach and culture
- Moving away from one-to-one agreements towards master agreements
- Reevaluating out-dated transfer policy
- Unifying systematic state-wide transfer
- Providing greater access, opportunity, and affordability
- Promoting collaboration and partnership
- Promoting radical **transparency** for the transfer audience

Agreements +Transfer Methodology

BUILDING UPON STATE TRANSFER POLICY FOR UNIFICATION

State- Specific Memorandums of Agreement

- Master document: roles, responsibilities, transfer methodology, policies and practices, recommendations, student support, incentives
- Key appendices: Institutional transfer policy alignment, Guiding Principles



Transfer and Articulation Policy (TAP)

BUILDING UPON STATE TRANSFER POLICY FOR UNIFICATION

- Passed by the Legislature in 2012 (Public Act 12-31) requiring Connecticut
 State Colleges and Universities to create seamless transfer pathways
- Currently consists of 25 Transfer Tickets
- Transfer Tickets are major to major pathways consistent throughout all 12 community colleges and aligned with the system's 4-year programs

Guiding Principles of the Guarantee

PUTTING STUDENTS AT THE CENTER

- Acknowledge and value the rich perspectives, life experiences, persistence, diversity, and the academic preparation community college transfer students bring to their institutions.
- Recognize the demographic challenges facing New England, and that community college transfer students are vitally essential to the future sustainability of both public and independent four-year institutions.
- Provide tailored pre-application and post-acceptance support services for transfer students, including: intensive advising, academic guidance and counseling, academic support, peer advising, personal guidance and counseling, transfer student orientations, career services and supplemental services.

Planning Grant Details

- Arthur Vining Davis Foundation & the Teagle Foundation 8-month \$50,000 planning grant (July 2021 - February 2022) to scale to ME, NH and VT.
- Subject to the success of the planning grant, NEBHE plans to submit a three-year implementation proposal in the spring of 2022.
